LAS VEGAS, NV - February 10, 2026 - Claiming duty-free treatment under the USMCA/CUSMA/T-MEC trade agreement should be straightforward - but for many importers and exporters, confirming origin eligibility and producing a valid certificate still creates friction. Without proper origin documentation, shipments entering the United States, Canada, or Mexico are typically subject to standard tariff rates. When a qualifying certificate is correctly completed, those same goods can generally enter duty-free, special tariffs aside. In an environment of escalating tariffs, trade remedies, retaliatory duties, and increased enforcement, getting duty treatment right has become a critical part of cost control and compliance.

Today at Manifest 2026, Zipments introduced its **USMCA/CUSMA/T-MEC Certificate App**, designed to make origin documentation faster, more structured, and easier to manage. The application replaces manual forms, PDFs, and fragmented tracking processes with a guided digital workflow.
